- Show respect for yourself, your team mates, officials, your opponents and their skills.
- Respect the rights and worth of every person.





- Behave in a manner that respects the rights of others regardless of mediums of communication used e.g. digital mediums such as Instagram, YouTube, Twitter, Facebook email and texts.
- Smoking, drinking of alcoholic beverages or the use of any illegal substances is strictly forbidden.
- Entering or remaining upon restricted licensed premises unless under the supervision of Team Officials or parents / guardians is strictly forbidden.
- Ensure you adequately prepare and recover for competition.
- Wear the official team uniform as directed by Team Officials.
- Check in and check out with Team Officials each day.
- Stay in the designated team area and support other team members during the event.
- Follow all directions of Team Officials.
- Ensure that you have telephone numbers of Team Managers at all times in case of emergency.

Parent and Community Code of Conduct

- Cooperate with the Team Officials to achieve the best outcomes for your child.
- Support team and event officials in maintaining a safe and respectful learning environment for all students.
- Maintain positive relationships with Team Officials regarding your child's learning, wellbeing and behaviour.
- Be courteous and constructive in your communication with players, Team Officials, game officials and sport administrators.
- Encourage honest effort, skilled performance and team loyalty.
- Behave in a manner that respects the rights of others regardless of mediums of communication used e.g. digital mediums such as as Instagram, YouTube, Twitter, Facebook, email and texts.
- Let game officials conduct events without interference.
- Demonstrate respect for opposing players and their supporters.

Breach of the Code

Team Managers and event organisers may deal immediately with any breaches of this code by warning offenders about their conduct, asking offenders to leave venues, and calling police to intervene where necessary. Queensland Representative School Sport is responsible for imposing any longer term consequences such as written warnings, or barring attendance at future events for a period or indefinitely.

Parents and spectators should note that it is an offence to insult (meaning "to treat insolently or with contemptuous rudeness, to abuse") an officer of a state educational institution - Section 333 Willful Disturbance, of the Education (General Provisions) Act 2006 (EGPA).

Parents and spectators will be afforded natural justice in respect of breaches of this code and for any discipline under the

Principal Approval:

Approval for your child to participate in the team must be given by the school Principal. The following factors will be considered by the Principal in deciding whether or not to approve your child's participation in the team:

- Current enrolment
- Ability to abide by the Code of Conduct

If the Principal does provide approval then the student is not eligible to accept the invitation to be a member of the team. If you are not satisfied with the principal's decision of not providing approval for your child to participate you are asked to contact the Principal directly to discuss the issue further.

Duty of Care:

During periods of team training, competition and other activities associated with the QRSS team program, your child will be under the sole direction and duty of care of the appointed Team Officials. At all other times during the event, you are responsible for your child.





Student Consent:

You will be required to complete a Queensland Representative School Sport Consent Form (students) detailing how your child's name, personal information and image may be used when participating in the representative school sport program.

Examples of personal information which may be used and disclosed (subject to consent) include the individual's name (first name and surname or part of their name), school, school year level, date of birth, age, sporting organisation personal identification number, image/photograph or voice/video recording. It is your choice whether to give consent. If you choose not to give consent your child will not be identified and images or recordings of them will not be published.

More information regarding personal information consent is contained in the **Representative School Sport Consent Form (students)**.

Student well-being & Injury management:

The health and welfare of students is a key priority of the representative school sport program. As such, should an injury occur during the event that results in a suspected concussion, the representative school sport Concussion Guidelines will be followed. This may mean that your child will not be permitted to take part in any further competition.

For all other injuries the advice of appointed sports medicine personnel / medical practitioners will be followed. This may mean that certification of a medical clearance to participate in full competition may be required prior to your child returning to the field of play.

From the time of team selection through to the conclusion of the event in which your child is participating it is your responsibility to ensure that Team Managers are fully informed regarding your child's ability to participate as a result of issues pertaining to:

- <u>Student well-being</u> concussion/suspected concussion/ injuries and illness that may impact on the safe participation of your child must be reported to Team Managers.
- School disciplinary action which may impact Principal approval to participate.
- <u>Disciplinary action resulting in suspension</u> from participation issued by the relevant State/National sporting organisation or affiliated member bodies.

Concussion:

The Department of Education is committed to the immediate and long-term safety and welfare of all students participating in the representative school sport program. Our Concussion management procedure along with the Concussion assessment and management booklet support the immediate and long-term safety and welfare of all students participating in the Queensland Representative School Sport (QRSS) program.

If a student is suspected of having, or has a concussion during this event, staff will contact emergency services, or request that the student seek medical advice. A student suspected of concussion will not be allowed to return to play for 48 hours after the incident. The doctor will either provide a medical clearance for the student to return to play, or write advice for sports staff and the school to follow to manage the student's concussion.

All representative school sport events held in Queensland must adhere to the QRSS Concussion management procedure and, where applicable, any additional National Sporting Organisation concussion management guidelines. QRSS recognise National Sporting Organisations are the experts in their sports, therefore, additional alignment to their concussion protocols ensures the utmost safety for students participating in all QRSS events.

- (c) photographic recordings of the individual/team during sporting events
- (d) written materials and reports recording information about the individual/team, including written summaries
- (e) annotated samples of the individual/team sporting performance, (including video or image)
- (f) representing Indigenous knowledge or culture.

Purpose

If consent is given in **Section B** below, the Department of Education (DoE) through Queensland Representative School Sport (QRSS) will be able to use, record, collect and/or disclose the Individual's personal information and/or materials to the relevant third-party, including sporting organisations, School Sport Australia, and/or education departments of other Australian state and territory governments for any of the following approved purposes:

- Travel agents, airlines and accommodation providers
- Non-employee volunteers as authorised by DoE to assist with facilitation, organisation and administration of representative school sport events, in roles including but not limited to coaches, managers, convenors and team marshalls
